| (revised) Chapter 1: General Policies (revised) Chapter 2: Standard Allowances | This chapter outlines general, overarching rules. Specifically addresses travel categories, traveler/component responsibilities, other basic travel info, travel orders, TDY time, limits, and receipts. This chapter outlines a traveler's standard allowances (transportation, per diem and miscellaneous reimbursable expenses); those that the traveler is most likely to be eligible to receive on most TDY travel. |

| (revised) Chapter 3: TDY Travel - Part A: Business - Part B: Training - Part C: Deployment, etc Part D: Medical - Part E: Leave in Conjunction | This chapter breaks TDY travel into major categories (business, training, etc.) and either states the standard travel and transportation allowances in Chapter 2 apply or provides variations in allowances based on the reason for travel. |
| (revised) Chapter 4: Government-Funded Leave | This chapter addresses leave funded the government including FEML, R&R, Special R&R, emergency leave, and emergency visitation. |

| (revised) Chapter 6: Evacuations | This chapter outlines traveler allowances for evacuations. |
