SUBJECT: CTD for CAP 44-15(I) -- Correct 4780-C – No Authority to Waive Terminal Parking Limit for Employee

1. **SYNOPSIS:** Corrects par. 4780-C to reflect there is no authority to waive the cost limitation of two one-way taxi fares for terminal parking in extenuating circumstances.
