SUBJECT: UTD/CTD for MAP 189-13(I)/CAP 189-13(I) – Add CBCA  
Decision Reinforcing Authorization to Amend Order to  
Show Original Intent

1. **SYNOPSIS:** Adds CBCA decision to JFTR/JTR, pars. U2205-A1a/ C2205-A1a, reinforcing that an order may be retroactively corrected to show the original intent. This item also adds an exception to JTR, par. C5810-E to allow for a mandatory authorization (BRAC move) that was omitted through error or inadvertence in preparing the order.
2. The attached revision is forwarded for information purposes only. No coordination or comments are required.
3. This revision was initiated by Staff.
4. These changes are scheduled to appear in JFTR change 324, and JTR change 578, dated 1 December 2013.
5. Revisions in this information item are *effective 9 October 2013*.

## JFTR REVISIONS

### U2205-A:

#### A. Modifications

##### 1. An order:

- a. May be retroactively corrected to show the original intent ([CBCA 3472-RELO, 23 September 2013](#)), and
- b. *Must not be revoked/modified retroactively to create/deny/change an allowance* ([24 Comp. Gen. 439 \(1944\)](#)). **Example:** After travel is completed, it would be improper to amend an order to 'un-authorize' POC travel that the order clearly permitted.

## JTR REVISIONS

### C2205-A:

#### A. Modifications

##### 1. An order:

- a. May be retroactively corrected to show the original intent ([CBCA 3472-RELO, 23 September 2013](#)), and
- b. *Must not be revoked/modified retroactively to create/deny/change an allowance* ([24 Comp. Gen. 439 \(1944\)](#)). **Example:** After travel is completed, it would be improper to amend an order to 'un-authorize' POC travel that the order clearly permitted.

### C5810-E:

E. Order. The authorization for Relocation Services must be on the original PCS order, even if contingent on circumstances (e.g., hardship situations after an aggressive attempt to sell the home) ICW APP I3, par. E1b(7). Exception: If mandatory authorization (BRAC move) was omitted through error or inadvertence in preparing the order (GSBCA 16437-RELO, 22 Sep 2004).
