SUBJECT: UTD/CTD for MAP 91-14(I)/CAP 91-14(I) -- NSA Regulations

1. **SYNOPSIS:** .Adds language that NSA employees and Armed Forces members working for NSA may be authorized DOS allowances IAW the National Security Act of 1959 (50 USC 3601 - 3617) if implemented in NSA regulations and provided duplicate allowances are not paid.

4. These changes are scheduled to appear in JFTR change 330 and JTR change 584, dated 1 June 2014.

*U1237 ASSIGNED TO NSA

A. Authority. An Armed Forces member assigned to NSA may be authorized DOS allowances IAW the National Security Act of 1959 (50 USC 3601-3617) if implemented in NSA regulations.

B. Duplicate Reimbursement. *A member may not receive an allowance under the NSA regulations and an allowance prescribed in the JFTR for the same purpose. The member is financially responsible for returning any duplicate travel and transportation allowances received.*

C1237:

*C1237 ASSIGNED TO NSA

A. Authority. An employee assigned to NSA may be authorized DOS allowances IAW the National Security Act of 1959 (50 USC 3601-3617) if implemented in NSA regulations.

B. Duplicate Reimbursement. *An employee may not receive an allowance under the NSA regulations and an allowance prescribed in the JTR for the same purpose. The employee is financially responsible for returning any duplicate travel and transportation allowances received.*
