SUBJECT: UTD/CTD for MAP 150-10(I)/CAP 115-10(I) -- R&R Travel  
Combined with other Authorized Travel

1. **SYNOPSIS:** This item reinserts wording that was erroneously deleted in MAP 42-10(I)/CAP 40-10(I). Because this item corrects erroneously deleted wording potentially affecting authorized travel, the effective date is backdated 1 August 2010, the date when the erroneous wording was published in the JFTR/JTR.

##### **C. Eligibility**

3.
