*a. When a traveler departs the PDS on leave and, because of an unforeseen circumstance, it is necessary to cancel the leave and recall the traveler to the PDS, return per diem and transportation expenses may be authorized.

B. Recall for Operational Reasons

1. *****

2. Eligible Member. An eligible member is one who departs from a PDS/TDY station on authorized leave and is recalled to the same duty station because of:

a. Actual contingency/emergency war operations, or

b. An urgent, unforeseen circumstance, when it is determined that:

(1) A substantial portion of the scheduled leave period has been eliminated by the recall, or

(2) The leave purpose has been defeated ([60 Comp. Gen. 648 \(1981\)](#)).
