SUBJECT: UTD/CTD for MAP 110-15(I)/CAP 110-15(I) -- FY16 Standard
CONUS Per Diem and Meal Ticket Rates

1. **SYNOPSIS:** The FY16 Standard CONUS per diem rate is \$140 (\$89/\$51) from \$129 (\$83/\$46) effective 1 September 2015 applicable for all official travel performed on or after 1 October 2015 to 30 September 2016. Meal ticket rate reimbursement is \$51 effective 1 October 2015. This item is implemented per [FTR 16-01](#) bulletin authority published in [Federal Register](#) publication of 1 September 2015.
