SUBJECT: Authorized and Ordered Departure Termination – Mongolia

The Department of State (DOS) has terminated the Authorized Departure from Embassy Ulaanbaatar, which includes all of Mongolia, for eligible family members (EFMs), including DoD EFMs, age 21 and over, and non-emergency civilian personnel, effective September 28, 2020. The DOS also has terminated the Ordered Departure from Mongolia for EFMs under the age of 21, including DoD EFMs, effective September 28, 2020.

DoD EFMs and non-emergency civilian personnel are therefore expected to depart for Mongolia in the most expeditious manner possible within 45 days of the effective date of the termination of the Authorized and Ordered Departure.

The Stop Forward Movement Order for travel to Mongolia, issued by my office on February 27, 2020, is terminated. Any travel to Mongolia must be in compliance with the May 22, 2020 Secretary of Defense Memorandum, "Transition to Conditions-based Phased Approach to Coronavirus Disease 2019 Personnel Movement and Travel Restrictions."
