SUBJECT: Ordered Departure — Indonesia and the U.S. Mission to the Association of  
Southeast Asian Nations

The Department of State (DOS) has approved an Ordered Departure from Embassy Jakarta and Consulates General Medan and Surabaya – which includes all of Indonesia – and the U.S. Mission to the Association of Southeast Asian Nations (ASEAN) of eligible family members under the age of 21, including DoD EFMs, effective March 25, 2020.

Paragraph 3.A.1.A of the March 24, 2020 Modification 1 to the DoD Response to Coronavirus-2019 Execute Order (EXORD MOD 1), approved by the Secretary of Defense, implemented a 60-day stop-movement of all international travel for DoD uniformed and civilian personnel and their sponsored family members not under the authority of a Chief of Mission.

DoD EFMs under the age of 21 may depart Indonesia by exception only, under the exceptions set forth in the EXORD MOD 1. Should an exception be granted, the designated safe-haven for departing DoD EFMs is the United States.

Stop Forward Movement: U.S. Government-funded travel to Indonesia for all DoD EFMs under the age of 21 is suspended pursuant to the EXORD MOD 1.

Any departing DoD EFMs of Service members will be processed for safe-haven allowances in accordance with the Joint Travel Regulations (JTR), Chapter 6 (Evacuation Travel), paragraph 0602. Any departing EFMs of DoD civilian employees will be processed for allowances in accordance with the JTR, Chapter 6, paragraph 0604.
